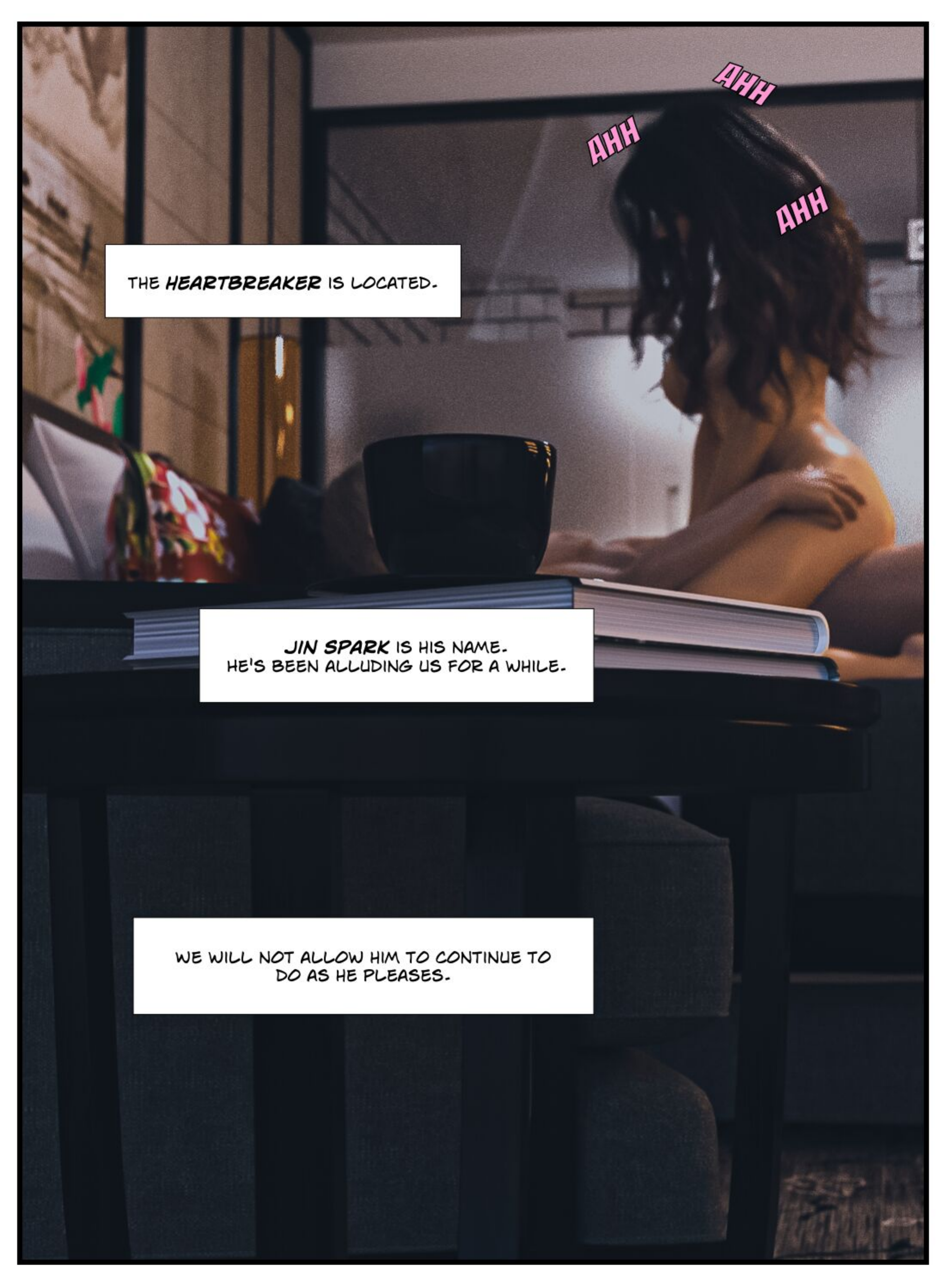
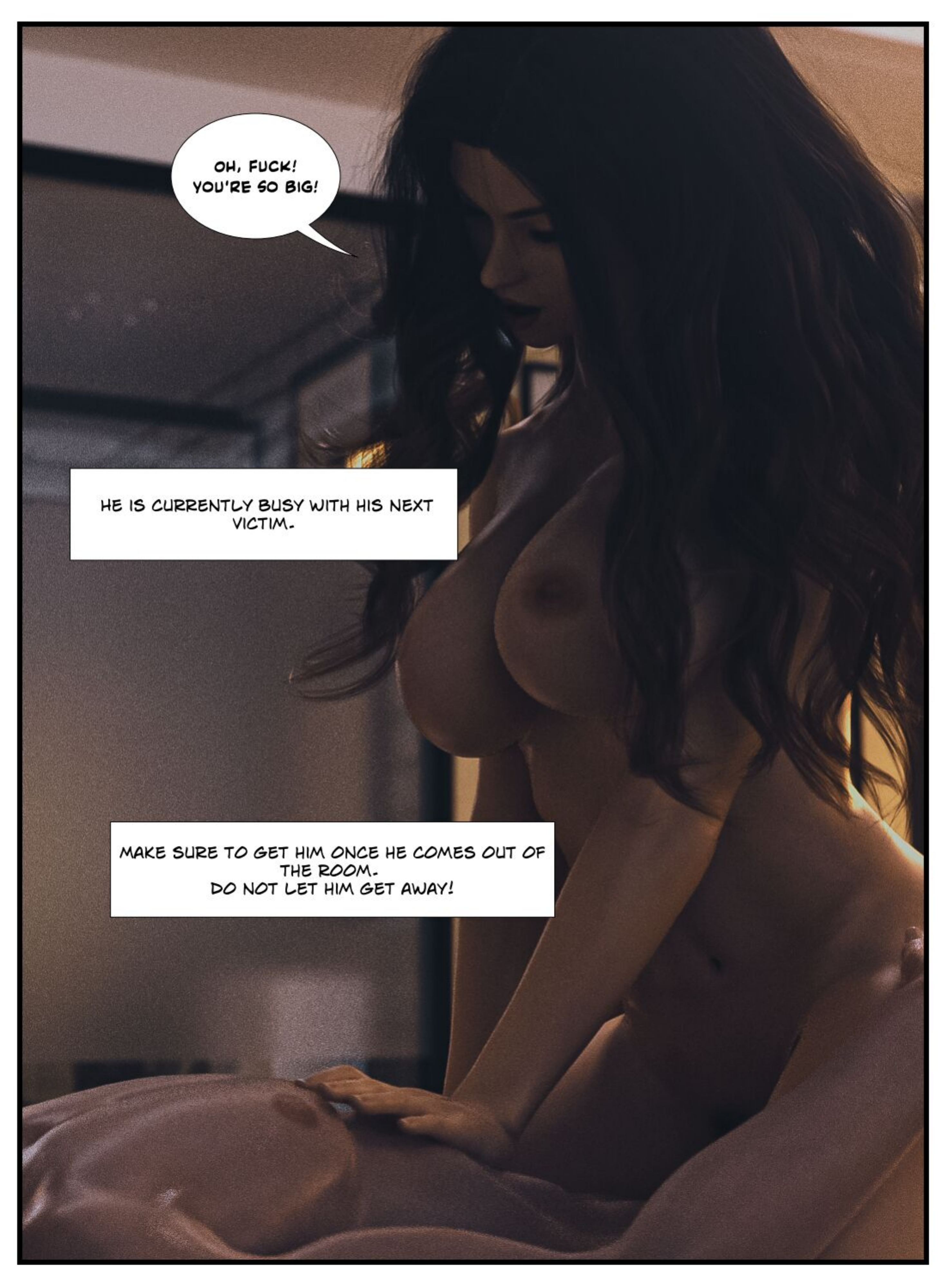




THE *HEARTBREAKER* IS LOCATED.

NOW!

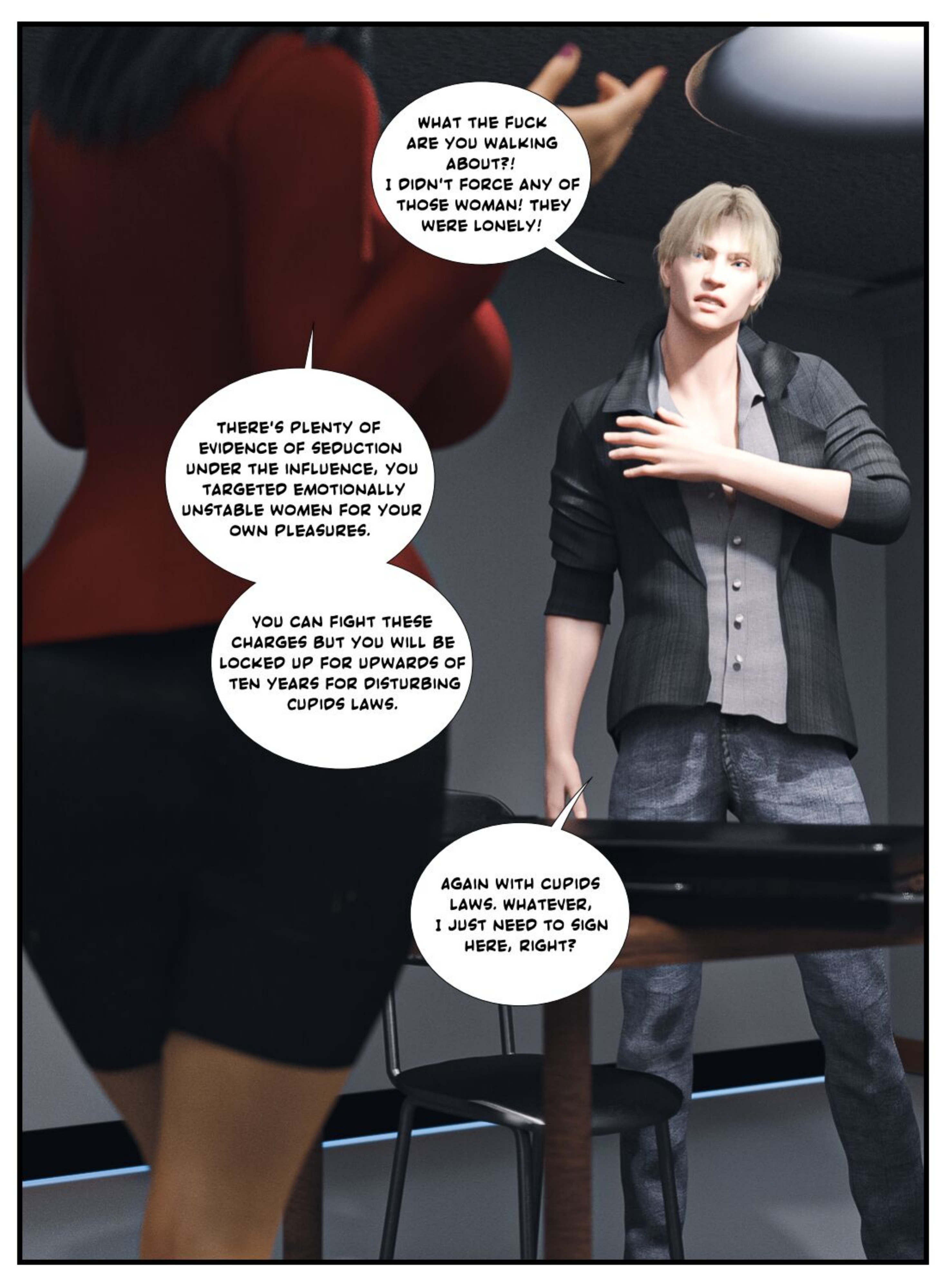


THIS IS NO JOKE,

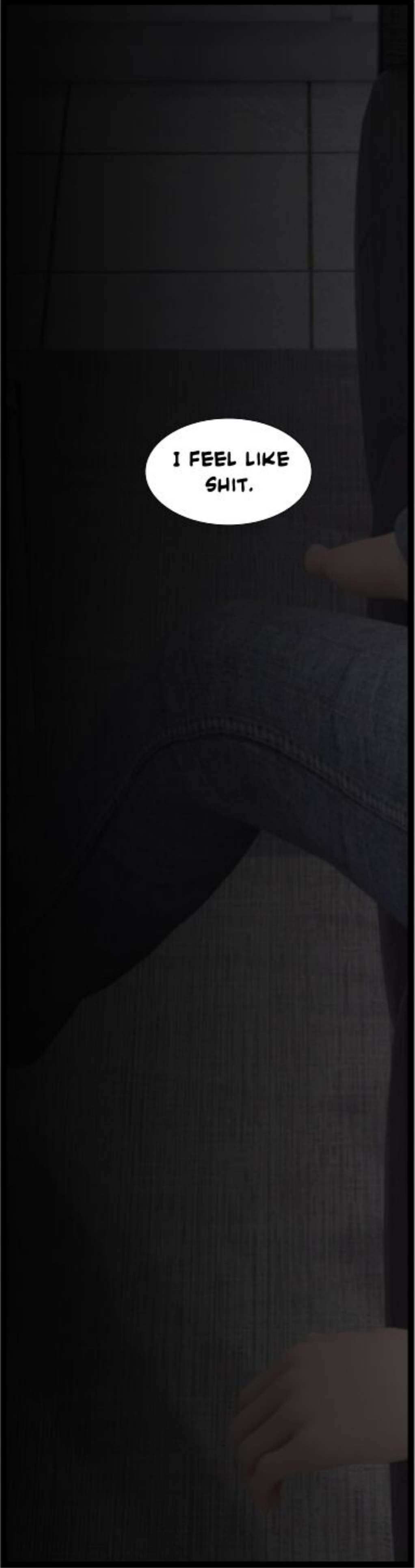
