Wound metallic wires form a tall humanoid regal form covered in ornate purple robes, the formed head crowned with a pure white headdress featuring no face. A large blue crystal embedded where a human's face would be glows as the creature speaks with a tone as if crystals were clattering in a miner's pouch. On closer inspection, the crystal head holds inside a skull, representing its past form before being ascended to an Atmari.

Aura of Conservance (abjuration, aura, divine) 20 feet, Allies within the atmari conservator's aura gain a maximum of 5 temporary hit points at the start of each of their turns, resistance 10 to positive damage, and are unharmed by the effects of a plane's positive traits.

Atma Vessel Those of the atmari are blessed to be conserved within an atma vessel. Their forms are able to be healed with positive energy and able to restore their bodies via crafting. But only true craftsmen from Amari will be able to effectively heal them. All attempts from a non-master in crafting instantly fail.

Speed 25 feet

Melee ♦ atma piercer +18 (magical), **Damage** 2d4+10 piercing

Divine Prepared Spells DC 30; **5th** divine wrath, remove curse, remove disease, remove fear; **4th** heal (x3), cloak of light; **3rd** Blindness, Crisis of Faith, Radiant Globe; **2nd** calm, dancing shield, dispel magic; **1st** Benediction, Bane, Bless; **Cantrips** (5th) divine lance, detect magic, shield (at will), stabilize, guidance.

Rite of Preservation ♦♦♦ (divine, transmutation) **Frequency** once per day; **Effect** The atmari conservator kneels down (gaining the prone condition) and begins to chant. Their Aura of Conservance deactivates. For the duration, an aura in a 30-foot emanation surrounds the conservator. All allies within the aura gain the effects of a 7th-level regenerate spell, but they regain only 5 Hit Points per round instead of 15. The conservator must use three actions for each of their turns to Sustain Activation of this ability. Each time the conservator has taken damage during the round, at the beginning of its turn they must succeed at a Will save (DC 34) or the ability ends. On a critical failure, the conservator convulses and explodes with positive energy, dealing 6d12 positive damage to all creatures within 30 feet.

LORE

"Blessed are those who bear his gift. Marked to take the road of ascension, let the Atmarak guide their way to eternal salvation."
- The Tome of Conservance, On the Duty of Faith

The Conservance teaches that their envoys must descend from the great hold to seek the blessed. To aid those through their Atmarak, the ascension of the soul. This is their primary mission, to roam the lands of Amari and find those who are afflicted by the cryst disease: crystal growths that tear through the body, threatening to consume its host in mind, body, and soul.

"The blessing is a test of will, to test if those chosen truly are deserving of his gift. Bring the child to the caretakers, the conservators, who shall guide the strayed to form. For those around them shall also be blessed, and shall be judged by their assistance."
- The Tome of Conservance, On the Duty of Kin

The Conservance warns that those who are found blessed must be reported or brought before the Conservance, to not do so would incur their wrath. They consider the blessings to be extremely sacred, and to ignore it is a terrible sin that brings calamity to those who neglect it.

"By your faith and service you shall be reborn, preserved in your image, preserved in your mind, preserved in your servitude to his design."
- The Tome of Conservance, On the Passage of Ascension

The faithful believe their minds and atma, their souls, are preserved, able to withstand the passage of time. They are granted new forms made from rune etched wood or metal by the Constructors, shaped to best represent the soul inside.

"Enemies are those who would lead our blessed astray, to divert them from his designs. All who would harm our family shall be put to the blade."
- The Tome of Conservance, On the Warning of the Unfaithful

Conservators, shepherds of the blessed, are not always seen as saviors. For those who oppose the faith, they see them as monsters. Slavers of the soul, subjugators of free willed beings who they think deserve peace through death rather than be eternally bound in servitude to the Conservance. For always when the Conservator visits a village, as if on schedule, a blessed is always found.
